




The Crossover by Kwame Alexander

Jane Elliott's Blue v.s. Brown Eyes Diversity Experiment

On April 5, 1968, one day after Martin Luther King Jr. was assassinated, Jane Elliott conducted an experiment with her 3rd Grade students on discrimination. When the students walked in that day, Ms. Elliott asked the kids how they thought it felt to be a black girl or boy. She suggested that it would be hard to understand discrimination without experiencing it. The students all agreed. She then divided the class based on eye color, rather than skin color.

For the first day of the experiment, Jane Elliott told the kids that the kids with brown eyes were superior to the kids with blue eyes. She convinced them with examples such as one blue eyed kid's father kicked him, and no brown eyed kid's father has. She then told the kids that the brown eyed kids had 5 minutes more time at recess, that only they were allowed to use the recess toys, and that the blue eyed kids could not sit with the brown eyed kids. Finally, Jane Elliott made all of the blue eyed kids wear a brown collar.

Jane Elliott then quizzed the kids. The blue eyed kids, even if they did well in school before, had a lower average grade on the test compared to the brown eyed kids grade.

The next day Jane Elliott flipped her statement, and said that the blue eyed kids were better, and again she used examples to support this. At recess that day, a few kids got into a fight, because some blue eyed kids were picking on brown eyed kids. When they took the test, the blue eyed kids did better than the brown eyed kids. This showed that when you think you are inferior, you act like it too.

At the end of this experiment, Jane Elliott explained to the kids that what they just experienced was discrimination. Although there are some flaws to the experiment, it teaches a really good lesson to the people experiencing it. When Jane Elliott conducted this same experiment on adults, they acted very similar to the kids. With some changes, this lesson should be taught in all schools.

Eagles Injuries 101

This year, the Eagles have been getting hit hard with injuries, sacks, and fumbles. Many fans are asking the common question: "How did we go from greatness to darkness so quickly?" There are a few common themes of the 2020 football season: Injuries, turnovers, and sacks.

When asked about the team's struggles, General Manager Howie Roseman said in January 2020, "One of the things that obviously has been an issue for us has been the injury situation. In 2017, we were able to overcome it. In the last two years, the injuries have really hurt our football team. Injuries are going to happen. But we have to figure out a way to get better here."

If you look at the Eagle's injury statistics, it is clear that the Eagles are having an increase of injuries each year. The chart below shows the total number of reported injuries from 51 in 2016 to 209 in 2019. To be fair, the NFL reported more injuries in 2019 than in previous years. Therefore, statistics may not be 100% correct, however, the increase is still shown.



Injuries increased an exceptional amount in 2018 and 2019: 69% and 137%, respectively. Some reasons for this increase may be age, skill or the COVID-19 pandemic. During COVID, players could not train or play during the pre-season as much as in other years. This could cause players to be out of shape, not stretched, or not ready to play when the season starts.

The chart above shows the total number of players on injured reserve by year. In 2019 and 2020 the Eagle's injuries are above the league average by 7% and 34%. If you consider the Eagles in 2017, they were 14% below the league average. But now, they are 34% above the league average. The Eagles average in 2020 is almost 3.3 times higher than in 2017. The increase seems unreal. Every year there have been soft tissue injuries, torn muscles, ACLs, stress fractures, you name it and we've had it!

The team's coach, Doug Peterson, is a little worried about this season's injuries as well. Not many people were impressed when Doug Peterson answered a reporter's question with, "It takes time for people to heal so just wait." Overall it might take a long time for this team to heal up and find new players that are young enough and able to play. Until then, the fans should watch every game with low expectations and I be grateful for each win.

Oculus Quest 2: Everything You Need to Know

Introduction

Just two months ago, on September 16th, 2020, Facebook/Oculus announced the Oculus Quest 2 at their yearly press conference, Facebook Connect. The Oculus Quest 2 is Facebook's hybrid VR headset and successor to the original Oculus Quest. It can run a fully tracked VR experience with no PC, external sensors, or phone required, making it a fully standalone VR headset. It also has the ability to play PCVR with Oculus Link and a compatible Gaming PC. Priced at just \$299, the Quest 2 is not just the cheapest VR headset out there, but also the best. So what makes it the best and how can Facebook make it so cheap?

What Is it?

For those few who have no idea what Virtual Reality or the Oculus Quest is, I will give a quick explanation. A virtual reality headset is a device that gets strapped to your head and has lenses and a screen inside. This allows you to get fully immersed in a game instead of just seeing it on a flat-screen device. It also includes two controllers so your hands and body can be in VR as well. But, these devices usually require a high-powered gaming PC and sensors. With the release of the Oculus Quest, you no longer need sensors or a gaming PC, all you need is the headset. Why It's The Best

Why It's The Best

As mentioned before, the Oculus Quest 2 is one of the best consumer VR headsets out there.

But why? First of all, the Oculus Quest 2 is a hybrid headset. This means that you can play VR without a Gaming PC, wires, or anything else needed, which is a luxury not many VR headsets have. What you get in the box is all you need for an immersive VR experience. But, if you own a Gaming PC and are looking to play PCVR, the Quest 2 can use Oculus Link to turn it into an amazing PCVR headset as well, allowing you to play thousands of games with great graphics.

Second of all, the specs. Now I could bore you by listing every spec, but here is all you really need. The Quest 2 features the brand new Qualcomm XR2 chip, making it at least 2x faster than the Quest I. It also features a resolution of 1832 x 1920 per eye, which is a massive step up from almost any VR headset out there, even ones priced at \$1000. Basically, it's a massive step up in every way, and it's almost like comparing the iPhone 12 to the iPhone 8. Finally, it features a redesigned controller that feels better and is stronger in your hand. Finally, it's Android operating system allows users to do all kinds of things, ranging from sideloading 3rd party apps (VR or not), all the way to loading an entire Linux operating system onto it, which I have recently done. This type of stuff allows you to get the most out of your Quest 2 and ensure you are using it to its full extent.

Issues With The Quest 2


As good as the Quest 2 is, there are some issues with it that need to be addressed. First of all, Oculus definitely had to cut back on materials to make it so cheap. The biggest example of this is the strap that goes around your head. The original Quest had a rubbery, springy strap while the Quest 2 has a flimsy fabric strap that is obviously cheaper to make. Luckily, Oculus has made a \$50 Elite Strap to compensate for this problem.

Another issue is the lack of a manual IPD slider. For the majority of you that don't know, IPD is the space between your eyes, and an IPD slider moves the lenses to fit your eyes. But the Quest 2

only has 3 preset IPD settings to switch between, so if you don't fit those the screen can be blurry. Finally, you need a Facebook account in order to use the headset. If you don't have one of those, you have to make one or you can't use the headset. It is very disappointing and is the main reason some people aren't buying these headsets.

Conclusion

In conclusion, the Oculus Quest 2 is a massive step above the original Quest and most other headsets. Not only can it play both standalone and PCVR, but it also has next-gen specs making it a cut above the rest. Sadly, it is made of cheap materials and requires a Facebook login, but those are minor issues. At just a \$300 price point, anyone can get into VR and have an amazing experience exploring new realities and conquering distant worlds.





The Tesla Cybertruck





There's No Place for Hate at Haverford



"Court Packing" in the USA: Past, Present, and Future

Upon the death of Associate Justice Ruth Bader Ginsburg on September 18, 2020, President Donald Trump nominated Amy Coney Barrett, who was a judge on the 7th Circuit Appellate Court, to fill the open seat on the Supreme Court. Just two months out from the 2020 Presidential Election, this nomination became a strong debate in the United States Senate. Barrett was confirmed with a 52-48 senate vote, one of the closest passing votes in history. Her confirmation gave conservatives a 6-3 edge on the court, with three of the six conservatives being Trump appointees. Upon fear of the democratic agenda, especially that of President Barack Obama and President-Elect Joe Biden being blocked, some democratic senators, including senator Sheldon Whitehouse (D-RI) and **S**enator Debbie Stabenow (D-MI) began to discuss court reform. This was quickly labeled by President Trump and Senate Majority Leader Mitch McConnell (R-KY) as an attempt to pack the courts, an imminent threat and abuse of power. People in our community and around the country on both sides of the aisle began to argue without knowledge of the Supreme Court's function and purpose, its history, and what "courtpacking" really is. Some argue that court-packing is adding justices to the court to create a majority of a greater number of justices. Others define it as a partisan shift in the court's power, keeping the

justices at any convenient number but confirming justices to secure a majority. To properly define the term, the court's history must be traced back to its conception.

America's Founding Fathers created a system of Checks and Balances to ensure that none of the three branches of government, the Executive Branch, the Legislative Branch, and the Judicial Branch, became too powerful. The Judicial Branch is responsible for keeping the other branches "in check" by following the standard of the laws outlined by the Constitution. The branch is kept "in check" by the legislative and executive branches as they preside over appointments to positions in the judiciary.

The highest court in the Judicial Branch is the Supreme Court. The Supreme Court hears cases who's original decisions and appellate level decisions are appealed by the non-prevailing party, with the hope that the decision could be reversed. The court is made up of nine justices--eight associates and one chief justice. The number of justices on the court has ranged from five to ten since its creation in 1789, with the number having been set at nine since the Judiciary Act of 1869. Since then, only once has there been an attempt to change the composition of the court. The Judicial Procedures Reform Bill of 1937, commonly referred to as "The Court-Packing Plan," (hence

Plan," (hence the label by Trump and McConnell) was an attempt by President Franklin D. Roosevelt to fill the court with up to six extra justices, for a total of 15, and to give the president the ability to appoint a new justice every time a sitting justice reached the age of 70 and failed to retire. The goal was to flip the court to a liberal majority and ensure that President Roosevelt's "New Deal" legislation, which the Supreme Court would have ruled unconstitutional, would pass. The judicial reform legislation was unveiled on February 5, 1937. Just weeks later, the Supreme Court ruled in favor of Washington state minimum wage legislation, the case West Coast Hotel Co. v. Parrish. This ended a period of the court known as the "Lochner Era" during which the court leaned conservative and tended to rule against business-regulation and pro-worker initiatives. They ruled businesses to be protected by the 14th amendment's "freedom of contract." Although the ruling in West Coast Hotel consisted of both conservative and liberal judges in the majority and the minority, the 5-4 pro-worker decision cited the constitution's protection of liberty, ruling that Washington's minimum wage law was a constitutional regulation of the 14th amendment's freedom of contract. Roosevelt's New Deal was much in line with this decision, as it was his legislation was strongly pro-worker, decidedly so to cope with

the economic strain of the Great Depression.

The decision kept Roosevelt from attempting to fill the court with pro-New Deal judges, as he no longer needed to do so to ensure victories for his administration.

Justice Owen Roberts's last-minute decision to vote in favor of mandatory minimum wage and switch the court's decision has been said to be "the switch in time that saved nine." Although Roberts never addressed the rumor and some scholars argue that he voted in accordance with his beliefs, not to save the court, his decision certainly prevented a major shift in the Supreme Court's balance for decades to come.

So where does this fit today? Much like FDR and the New Deal, modern democrats are worried that a conservative majority in the court, solidified by Amy Coney Barrett's confirmation along with conservatives Brett Kavanaugh, Neil Gorsuch, Samuel Alito, Clarence Thomas and swing vote Chief Justice John Roberts will beat out the court's three liberal justices, Stephen Breyer, Sonia Sotomayor and Elena Kagan, and will block democratic initiatives including those pertaining to the Affordable Care Act (also known as Obamacare) and decisions pertaining to women's reproductive rights, originally decided in 1973 case *Roe v. Wade*.

"Court Packing" in the USA: Past, Present, and Future (cont.)

It has been argued that President Trump "packed the court," as he confirmed three justices for a 6-3 conservative majority (5-4 with Roberts's occasional swing). But, if the term "court-packing" is used in its original form, as it was by republican leadership in the 1930s, it is more accurately defined as an addition of justices to the original nine to create a majority, not appointing justices as replacements when a sitting justice retires or dies to swing the majority.

The Supreme Court became a topic at both presidential debates and the vice presidential debate. Many people in the country and in our community were quick to take a position--ranging from those wishing to ensure a conservative majority calling court reform "dangerous" to those with more liberal agendas calling for justices to be added to our nation's higher court if Vice President Joe Biden were to be our next president **.

Only you can decide where you stand. What is more important? The partisanship of the courts or the integrity of our government's checks and balances system, created to prevent executive overstep? Is addition of justices abuse of power by the executive branch? Or is the true abuse appointing multiple conservative justices in a short time to change the views of the court for generations?

The 2020 Presidential Election

The 2020 presidential election has been one of the most important and anticipated elections in recent history. With COVID-19 continuing to spread in our country and the country more divided than ever, the U.S. people voted for their leader for the next four years. The race pitted Republicans' billionaire businessman and incumbent president Donald Trump and Vice President Mike Pence against Democrats' former Vice President Joe Biden and California's Senator Kamala Harris. Tensions were high leading up to the election, and the two candidates' messages could not have been more different. President Trump was set on making sure his agenda continued to be followed. He was fixed on reopening the country as fast as possible, and bringing the economy back to form no matter what the cost. Biden, on the other hand, preached of togetherness and unity. He wanted to open the country slowly, and save as many lives as possible, even if it hurt the economy. The two also relentlessly went after each other. Trump bashed Biden's son Hunter on rumors of business deals with the Russians, and also went after Biden's past support of the now controversial 1994 Crime Bill. Biden made sure to attack Trump on alleged collusion with the Russian government, and Trump's 2020 impeachment. After what felt like an eternity, November 3rd came and people came out in record numbers to vote. Over 151,000,000, around 68% of the voting population, came out to vote, with around 101,000,000 people voting early.

As polls closed and votes started to be tallied, President Trump jumped out to an early lead, with massive leads in the key battleground states of Pennsylvania, Wisconsin, Michigan, and Georgia. The world watched as votes were counted and Donald Trump's lead continued to grow. Things were looking so good for the sitting President that he declared victory at 2:30 in the morning on November 4, the day after the election. However, by the morning, President Trump's leads had shrunk. This trend continued across the country, and by 5:00 pm on November 4, the media was able to project the key battleground states of Michigan and Wisconsin for Joe Biden, bringing Biden's number of votes to 253, with Trump at 214. The race was not over, though, as the races in Pennsylvania, North Carolina, Georgia, Arizona, and Nevada were still too close to call. As the next two days passed, Biden continued to catch up in the states in which he was behind and grow his lead in the states in which he was ahead. Finally, at around 11:00 on November 7, the media was able to predict loe Biden as the 46th president elect of the United States, with wins in Pennsylvania and Nevada. Over the next week, North Carolina and Alaska were called for President Trump, and Arizona and Georgia were called for Vice President Biden.


This brought the final electoral vote to 306 for Biden and 232 for Trump, with Biden also winning the popular vote by over 5,000,000 and counting.

Though the media and most of the country agree that Joe Biden is the president-elect, Trump and his legion of supporters are sceptical. Even before the election, President Trump made it clear that he would not accept the results of the election, and that he would fight the counting of the mail-in-ballots. President Trump and his team filed lawsuits in Pennsylvania, Georgia, Wisconsin, Arizona, and Michigan, to try to stop the counting of cast mail-in-ballots by claiming illegality and fraud. When these lawsuits fell through, and Trump's lawyers admitted that there was no evidence of fraud, the Trump campaign pivoted, and filed new lawsuits claiming that Republican poll watchers were not allowed to watch the counting of mail-in-

ballots as closely as Democratic poll watchers.

There is no evidence of these claims, and there is video proof that disproves them. Still, Trump and his lead attorney former New York City Mayor Rudy Giuliani continue to discount the election and to undermine the legitimacy of the election.

As the lawsuits continue to be dismissed and states continue to certify their election results, Trump's legal path to winning the election is shrinking. Joe Biden is set to be inaugurated on January 20, and Donald Trump will have no choice but to vacate the White House. As one of the most anticipated and divided elections in history comes to a close, the peaceful transition of power that has been practiced in the U.S. for over 200 years will be put to the test as Joe Biden prepares to become the 46th president in the midst of a global pandemic and one of the most polarizing times in our country's history.

"Creating an Inviting Language Classroom through Empathy"

New to Haverford this year, Ms. Daphne Monroy is currently teaching 6th grade and Form I Chinese. One of the professional goals she set up in the beginning of this year was to create an inviting classroom through Empathy. On the first day of the school, she asked for the definition of Empathy, and one student replied with a perfect answer: "Put yourself in other people's shoes." Ms. Monroy then explained what students could do with Empathy in the Chinese classroom. After she created a name tag for each student, Ms. Monroy started to go around the room and say their names. She pronounced the familiar names correctly, but after mispronouncing a few of the student names, Ms. Monroy stopped and shared how she felt. Ms. Monroy explained this is exactly what they were going to experience when learning Chinese—anxiety, nervousness, frustration, making mistakes over and over, etc..

On the second day, Ms. Monroy made the same mistakes again when she tried to pronounce a few of the students' names! And yes, this happens to second language learners as well—they might make the same mistakes again and again until they "notice" their mistakes and eventually are able to "self-correct" themselves. Starting on the second day, the students were getting comfortable in sharing their feelings, and some of them admitted that they did not pronounce their classmates' names correctly either. Ms. Monroy explained further that she was creating a safe and mutually trusting environment in which students feel comfortable to speak a second language and to share their feelings. She promised students that nobody's pronunciation would be laughed at because of the Empathy that everyone embraces.



Finally, on the third day, Ms. Monroy thought she was almost perfect, but she still made a mistake with one student's last name. That student shared that most teachers did not pronounce his last name correctly.

Ms. Monroy was determined to pronounce everybody's English name perfectly, even though she was going to give each student a Chinese name. With Empathy in mind, she does not want students to become perfectionists like her because some of the characteristics of a perfectionist are not beneficial when learning to speak a second language. For example, being afraid of making mistakes might increase delays of production in speaking a second language. Consequently, Ms. Monroy encouraged the students to follow a rule of thumb for learning a second language: "To make a lot of mistakes." **R**egarding the phrase, "practice makes perfect," Ms. Monroy replaced "practice" with "mistakes" to help students understand it's OKAY to make mistakes and not to be afraid of mistakes.

Everyone knows how intimidating it can be to speak a second language, and it is definitely not easy to get out of one's comfort zone to speak a second language. Fortunately, with Empathy and the inviting classroom Ms. Monroy created, some students shared that Chinese has become their favorite class within just a short one and a half weeks. Ms. Monroy is also very proud of her students being willing to take risks in speaking. She could not be happier with her classes, it's a win-win!

This is an exaggerated true story of my experience rescuing neglected dogs from an Amish farm with Bill Smith, owner and creator of I Love 4 Animals, a non-profit animal rescue located in Chester Springs (For more information, visit https://www.llove4animals.org/).

The first section is my experience and my perspective. The themes we see coming through are curiosity and nervousness. Bill and I arrived at around ten at night. The Amish farm was large, and no trace of electricity could be found. The man who came to greet us was clad in stereotypical farmer clothing: a tan straw hat, overalls, etc. We were there to pick up overage breeding dogs who could no longer be bred, and therefore the Amish could no longer profit from them. Many Amish euthanize their overage dogs, but these particular Amish had a pocket of sympathy in their hearts and turned the dogs over to us.

The second section is the perspective of the dog being rescued. Portrayed are feelings of confusion, desperation, and blind hope. The dog has spent all of his life cooped up in a rabbit hutch with a wire bottom, living in horrible conditions.

Last is the Amish farmer's perspective.

The reader gets the sense that he feels guilty and uncomfortable. We often think of his practice (involving animals) as cruel, and inhumane, but in

his society, this is the usual. He does this to make money, and feed his family.

This is NOT meant to be a personal narrative, but instead a demonstration of how three living creatures can see the same thing in three different ways. The boy is shocked by how the dogs are treated and automatically does not like the farmer. The dog isn't quite sure what is going on, but can sense that good is about to come his way. And finally, the Amish farmer is just going about everyday business and providing for his family, doing what he sees necessary. I hope you enjoy it.}

My Perspective

Our large SUV twisted and turned through the narrow gravel road, the only light coming from the car's headlights. Bill and I finally reached the living quarters of this particular Amish farm, at around 10:00 pm. We got out of the car, slipped our phones in our pockets (If we were going to be kidnapped by these farmers, I would at least need some Family Guy to binge-watch), and knocked on the first door we saw. Out emerged a tall man wearing tan clothes and a dark brown straw hat. He had dark brown hair tied back in a bun, a flickering lamp that he held loosely in his hand, and didn't look happy to see us.
